RE: Northeast Carpenters Annuity Fund

To All Participants of the Annuity Fund:

If you have a loan currently in repayment with the Fund, or you applied for a loan on or after March 27, 2020, you may be eligible to delay for a period of one year any loan payments that would otherwise be due between March 27, 2020 and December 31, 2020. **Please note: After deferment is completed all future loan payments will be adjusted to reflect the delayed due date and increased to add any interest accrued during the delayed period.**

The loan repayment deferral identified above is available to all who submit a request in writing and who certify to the Fund that they fall into any one of the below three categories:

1. Have been diagnosed with the virus SARS-CoV-2 or COVID-19 from a CDC approved test.
2. Have a spouse or dependent who has been diagnosed with the virus SARS-CoV-2 or COVID-19 from a CDC approved test.
3. Have suffered financial consequences as a result of being quarantined, being furloughed or laid off or having work hours reduced due to such virus or disease, being unable to work due to lack of child care due to such virus or disease, closing or reducing hours of a business owned or operated by the individual due to such virus or disease.

A copy of the required request and certification form is enclosed. If you do not submit this form, you will not be eligible for the loan repayment deferral.
